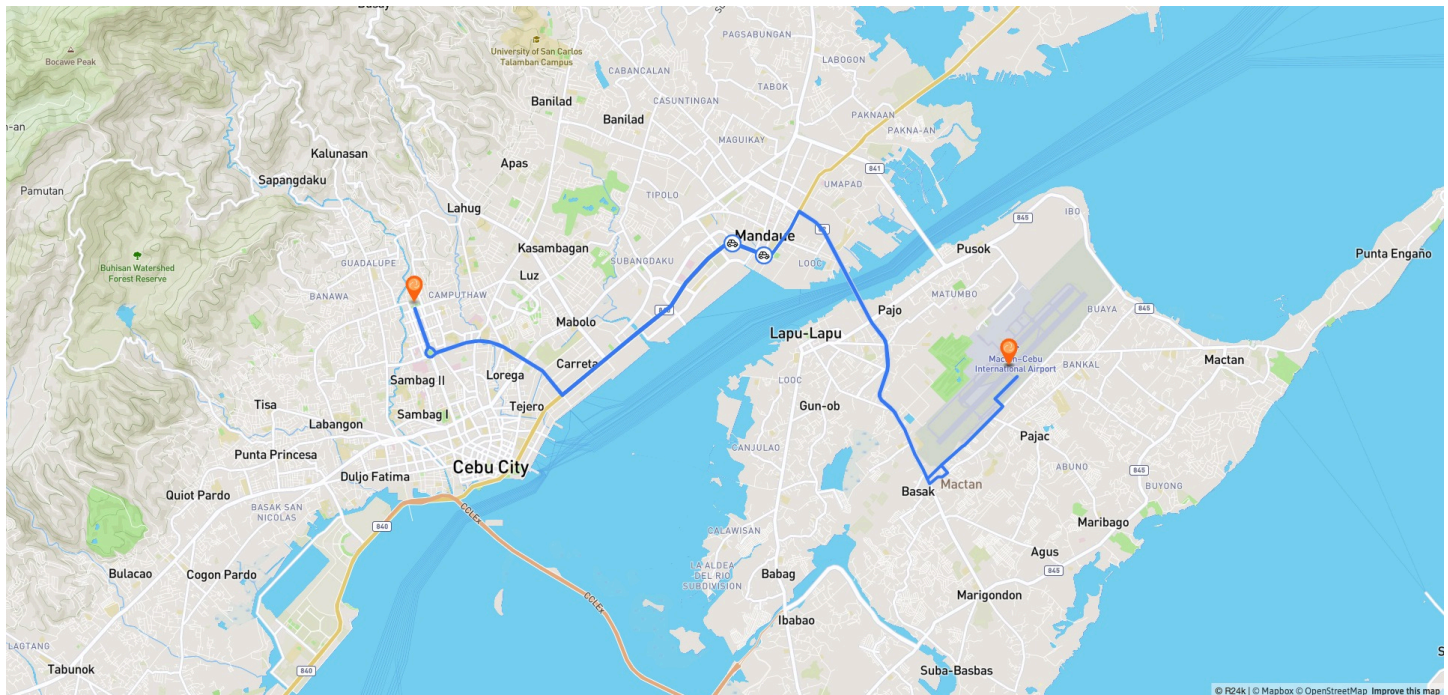

Cancellation Policy

In case you need to cancel the tour we need to be informed by email. Cancellation fee will be as written below:

- Up to 30 days before "Trip Start Date" a cancellation fee equal to the previously agreed down payment or equal to 20%.
- Between 15 and 29 days before "Trip Start Date" a penalty of 30%, the remaining amount will be refunded.
- Between 7 and 14 days before "Trip Start Date" a penalty of 60%, the remaining amount will be refunded.
- 6 or less days before "Trip Start Date" or in the event of a no-show, 90% of the total amount is due.



Travellers responsibility

The responsibility lies with the traveler to have a valid passport, visa, vaccinations and preventive medicine during the travel period, as required by the authorities of the visited countries. The information of those related subjects, to the best of our knowledge, are given by the different national authorities and is delivered as non-binding advice, therefore, you cannot derive any rights. The traveler retains his right to transfer the travel agreement to another traveler according to section L. 211-11. The traveler is required to report any negative performance during the travel or stay as soon as possible according to II of section L.11-16.
